#### 2.0 Section-Sponsored Research and Applications

#### 2.1 Research

#### 2.1.1 Anti-Fatique Mat Study

Three members of the student section, under the tutelage of Dr. Chris Grieshaber, directed a workplace anti-fatigue mat survey. Five other student section members assisted with the logistics of this project. Participants of the survey were primarily Illinois State University faculty, students and staff. The purpose of the survey was to measure the perceived ratings of discomfort during prolonged standing across three different types of surfaces: air-filled anti-fatigue mat, foam anti-fatigue mat, and the floor (no antifatigue mat). Student researchers presented their findings at the Applied Ergonomics Conference in Orlando, Florida in March 2017 and the Illinois State University Research Symposium in Normal, IL in March 2017 (See March 2017 Newsletter in Appendix D). Students will also be presenting at the ASSE Professional Development Conference, Safety 2017 in Denver, CO this summer. See Appendix C for further details regarding this research project.

#### 3.0 Community Involvement

#### 3.1 Section-sponsored community activities

#### 3.1.1 Trick-or-Treat Bags Donation

The student section purchased Halloween Trick-or-Treat bags with safety messages on them. These were donated to Bright Horizons Daycare and Preschool and Cedar Ridge Elementary School in Bloomington, IL.

#### 3.2 Section-sponsored campus activities

#### 3.2.1 Homecoming Coffee Tent

The student section continued a tradition that was started almost thirty years ago of setting up the Homecoming Coffee Tent along the pre-game parade route on campus. Many safety alumni who attend the homecoming game and festivities stopped by the Homecoming Tent to visit with faculty and current students. The student section purchases coffee, soda pop, water, donuts and cookies and asks for donations from spectators along the parade route. A tradition that started in 2015 was to donate all proceeds to the ASSE Foundation. Four student members helped to set up the tent and coffee along with two safety program faculty. Seven student members worked the tent during the parade (See October 2016 Newsletter in Appendix D).

#### 3.2.2 Linked-In Workshop

The student section sponsored a Linked-In workshop for members and other programs on October 27, 2016. Ms. Andrea De Cola, a Student Ambassador from the ISU Career Center gave advice for students on developing a Linked-In page to develop their own 'brand" in career networking (see October Newsletter in Appendix D). The attendance from other programs was not good, but we did have eleven student members and one faculty member attended this function.

#### 3.2.3 American Heart Association Heartsaver CPR Certification

Three student section members, Nora Fredstrom, Meredith Vespers and Fanny Bowers, are certified to teach CPR (American Heart Association) and volunteered to teach CPR on February 23, 2017 (see February 2017 Newsletter in Appendix D). This was open to all programs in the Department of Health Sciences and other invited departments across campus. Twenty-four student section members, two safety program faculty and one other major attended this event. Ms. Fredstrom, Ms. Vespers, and Ms. Bowers are currently working with other student organizations in the Department of Health Sciences to schedule CPR certification classes, including AIHA and SEHA.

#### 3.3 Section participation in community activities:

#### 3.3.1 Boys Scouts of America

On November 11, 2016, three student section members and one safety faculty member worked with the W. D. Boyce Council of the Boy Scouts of America to help unload and organize popcorn for the annual Boy Scouts fundraiser. Students assisted in the organization, sorting, and distribution of over 2000 items. The student section's assistance enabled the process to be completed in record time (see November-December 2016 Newsletter in Appendix D).

#### 3.3.2 Festival of Trees for the Baby Fold

On November 15, 2016, three student section members and two safety program faculty volunteered for the Festival of Trees in Bloomington, IL. This group helped to set up the hundreds of Christmas trees at the Bloomington-Normal Interstate Center to be sold for the Baby Fold's annual fundraiser. The Baby Fold is a statewide program that assists emotionally and physically abused children. Their goal is to improve the children's lives through foster care, education and other services. This year, the Festival of Trees raised over \$200,000 to aid our local community's Baby Fold operation (see November-December 2016 Newsletter in Appendix D).

#### 3.3.3 DIOSH Day

Downstate Illinois Occupational Safety and Health (DIOSH) Day is an annual, one day safety conference held in Peoria, IL. The planning committee asks that 6 student volunteers help with registration and lunch lines. In return, the Safety Program is given a booth in the exhibitor hall free of charge. The booth is a great opportunity for safety alumni who attend to visit with faculty. On March 1, 2017, seven student section members worked to stuff attendee bags and help with registration, beginning their day at 6 am. The members also attended conference sessions after completing their assigned tasks. Four board members and three other members participated (see March 2017 Newsletter in Appendix D).

#### 3.4 Section participation in campus activities:

#### 3.4.1 Festival ISU Fire Extinguisher Training

Festival ISU is an annual back-to-school event. Festival ISU allows all students to visit booths for approximately 400 different organizations in and around ISU. ISU Environmental Health and Safety (EHS) provided training and hands-on demonstrations of fire extinguisher use to students. On September 1, 2016, 8 student section members help the EHS office at Festival ISU by operating the Bullex Grill systems, recharging fire extinguishers with water and pressure, and teaching hundreds of students the "PASS" method for extinguishing fires (see September 2016 Newsletter in Appendix D).

#### 3.5 Section engagement with and/or support of the ASSE Foundation:

#### 3.5.1 ASSE Foundation Donation

The student section raised \$220.00 in donations at their annual Homecoming parade coffee tent (see October 2016 Newsletter in Appendix D). The student section discussed and voted on adding \$80 to the amount raised to make a total contribution to the ASSE Foundation of \$300 (see November-December 2016 Newsletter in Appendix D). The members who attended the Future Leaders Safety Conference (FLSC) then presented the check to Dr. Darryl C. Hill, Director of the Foundations Board of Trustees and Mr. Michael Murray, Past Chair of the Foundation's Board of Trustees (see November-December 2016 Newsletter in Appendix D).

#### 3.5.2 Other ASSE Foundation Involvement

The student section supports the ASSE Foundation in several ways. At the beginning of the academic year at our Fall Kick-Off Meeting, faculty and student section executive board members promoted Foundation news and ideas. The board provided information about the Foundation's mission, scholarships, and the Future Safety Leader's Conference. Additionally, throughout the Fall semester, board members provided reminders about scholarship application deadlines. Finally, several of our members have attended CIL-ASSE Parent Chapter meetings and the Illinois State University Safety Program Advisory Board meetings to discussed opportunities for alumni and professionals to assist the student section by supporting the ASSE Foundation.

#### 4.0 Recognition

#### 4.1 Scholarships

Dan Bowe, student section President, received the ASSE Student Section Chairperson Award in 2016, which is awarded to the President of the student section each year. As the recipient of this award, Mr. Bowe served on the Safety Program Advisory Board for the 2016-2017 Academic Year.

Jeff Bajema, student section Vice President, received the 2016 John A. Leonowich Award from AIHA for research in non-ionizing radiation. Mr. Bajema also was selected as the Safety Department 2017 OMRON Safety Scholar. Additionally, Mr. Bajema received the 2017 ASSE Foundation Construction Safety Scholarship.

Nora Fredstrom, student section Secretary, received scholarships from the Board of Certified Safety Professionals (BCSP) and Campus Safety Health and Environmental Management Association (CSHEMA). Ms. Fredstrom also received a UPS Scholarship from the ASSE Foundation in 2016. Additionally, Ms. Fredstrom was the first ever Safety major to be named a Bone Scholar, which is the highest honor an undergraduate student can receive at Illinois State University.

Justin Artman, student section Community Relations and Social Chair, has received the 2017 Applications International Corporation Impact Scholarship from the ASSE Foundation, the 2017 American Society of Safety Engineers Central Illinois Chapter John "Gary" Erisman Memorial Scholarship, and the Safety Department 2017 Ronald Budig Leadership Award. Mr. Artman also received the Paul Ronczkowski Student Alumni scholarship in 2016. As the recipient of this award, Mr. Artman served on the Safety Program Advisory Board for the 2016-2017 Academic Year. Additionally, Mr. Artman is a finalist for the Illinois AMVETS Service Foundation Scholarship.

Sarai Villegas, student safety major, was named the 2017 ADM Safety Scholar. Ms. Villegas is not currently a member of the student section.

#### 4.2 Committee Membership

Nora Fredstrom, student section Secretary, was reappointed for a second term as an associate member on the American Chemical Society Committee on Chemical Safety. She is the first and only undergraduate to serve on this committee.

#### 4.3 Invited Conference Presentation

Nora Fredstrom, student section Secretary, accepted an invitation in March 2017 from the President of the American Chemical Society to speak at a Presidential Symposium at the American Chemical Society National Meeting in Washington, D.C. in August 2017 on building a safety culture across the chemical enterprise.

#### 5.0 <u>Student Section Participation</u>

#### 5.1 Membership

Illinois State University Student Section ASSE membership is comprised primarily of undergraduate Safety majors. Three of our members are Environmental Health majors, two of whom are pursuing Safety minors. One member is a graduate student in Agriculture, pursing a thesis in Agriculture Safety. Currently, 40% of Safety majors are ASSE members.

To whom it may concern,

I am writing this letter in support of the Illinois State University (ISU) Student Section of the American Society of Safety Engineers' application for Outstanding Student Section. My name is Dr. Chris Grieshaber. I am an associate professor and the director of the Safety Program in the Department of Health Sciences at ISU. I have had the pleasure of working with the student section board members and membership at-large this year in several capacities, most notably, the research project. As with any organization in which the leadership changes annually, the success and quality of the student section from year to year tends to vary. This year's group at ISU has been nothing short of exceptional. I believe the ISU section is deserving of recognition in this process because of their hard work to increase membership, their professional commitment to the parent chapter and campus community, their commitment to providing quality learning opportunities and experiences for the section members, and their enthusiasm for spreading the important message about the need to protect people, property, and the environment.

As an example of the quality work this group has been doing, the members decided to conduct a research analysis of anti-fatigue mats. A new technology – air-filled mats – was being promoted in the market and the students wanted to compare user perceptions of the new mat with those of other mats. We met in the fall and I laid out for them the process by which they would need to collect and analyze data in order to have any chance of presenting their results professionally – a goal they had set for themselves early in the conversation. From that point forward the students set up and conducted their analysis with minimal assistance from me. Student volunteers (under the leadership of Justin Artman, Nora Fredstrom, Meredith Vesper and Jeff Bajema) delivered the mats, obtained participant consent, and collected and analyzed survey results. The findings were accepted and presented as a poster at the 2017 Applied Ergonomics Conference in Florida. The section will also present their findings at the Undergraduate Research Symposium on campus on March 31. The board members have demonstrated significant leadership in organizing and training student volunteers for the study, which has taken place over a period of 14 weeks and two semesters. In total, almost 900 hours worth of data were collected with the help of seven student volunteers. The effort put forth in conducting this small research study is indicative of the quality and excellence of the ISU student section in 2016-2017.

I highly recommend the 2016-2017 student section of the Central Illinois Chapter of ASSE as an outstanding student section.

As new flooring technologies emerge in the market, there continues to be a need to assess the effectiveness of those surfaces in reducing worker discomfort and fatigue – in particular, those associated with musculoskeletal disorders of the lower extremities.

#### Objective

To assess the effect that an inflatible anti-fatigue mat has on worker discomfort compared to other work surfaces





#### Methods

#### **Participants**

Volunteers for this study were selected from a working population in and around a university community who averaged at least two hours of standing work during a normal working day. Volunteers who self-reported musculoskeletal disorders of lower extremities were asked not to participate.

#### Self-Administered Questionnaire

IRB-approved written consent; survey responses submitted anonymously using a modified version of Cornell Musculoskeletal Discomfort Questionnaire (Hedge, Morimoto, McCrobie, 1999; Harich, 2002). Three mat conditions surveyed (randomized, repeated) over a six-day trial. Participants surveyed once pre-trail and again at the end of each workday.

#### **Findings**

- Avg. time spent standing during workday: 3.4 ± 1.1 hours (n=37); no significant differences between time spent on each surface.
- Participants reported significantly higher job satisfaction when standing on the foam (6.0) and air (5.5) anti-fatigue mat surfaces when compared to a no mat condition (3.3, p < 0.01)</li>
- Participants reported significantly lower ratings of discomfort for the hips/legs (p < 0.05) and feet (p < 0.01) over the no mat control condition</li>
- For all reported body locations except the knees and forearm, the foam mat and air-filled mat resulted in lower ratings of discomfort than the no mat control.







Growmark also has approximately 100 grain handling facilities. There is a construction division that builds grain storage systems and other agricultural facilities. HAZWOPER is a big part of the industry. Training on anhydrous ammonia is also a big part of Growmark's responsibility.

Mr. Frye spoke on the changes to Growmark following the disaster in West Texas. There was an explosion of a fertilizer plant due to ammonium nitrate. As a result, new regulations were handed down regarding process safety management, which Growmark worked quickly to adapt to. Growmark works to make sure emergency respond-



Mr. Frye also covered some of the DOT regulations that apply to Growmark, which was a unique learning opportunity for the ASSE Students in attendance. Mr. Frye sees the two "hats" he wears as a safety professional as both regulatory compliance and loss prevention. As a response, Mr. Frye developed a Supervisor Boot Camp, a two-day intensive, which provides supervisors the safety training they need to be effective. This camp has been highly successful in creating safety culture.

ISU ASSE Student Section would like to thank Mr. Frye for his presentation both at ISU on November 1 and at the Parent Chapter Meeting on November 8.

# Professional Development: CPR Certification







Mr. Ritchie then presented how a behavioral approach to safety can turn a safety program around. Mr. Ritchie explained it is important in safety that we connect the low-level actions to the high-level impacts. Mr. Ritchie believes that increasing

#### Featured Technical Presentation: Angela Banerjee, Acuity Loss Control



On March 23, 2017, Illinois State University ASSE Student Section welcomed Angela Banerjee, Director of Loss Control at Acuity. Ms. Banerjee is an alum of the ISU Safety Program, and presented on Loss Analyses, Spreadsheets, and Pivot Tables.

Ms. Banerjee began by discussing Target Loss Drivers, or what type of losses are resulting in the greatest cost. There are both internal and external claim/loss data sources. If your company does not have a lot of internal data, Ms. Banerjee recommends benchmarking data sources, OSHA Establishment Searches, and BLS Data. These resources can be used to determine what other companies are experiencing in terms of losses.

Workers' Compensation claims, OSHA logs, near miss reports, and others to look at track number, costs, and lost time/restricted work days. This data can be compared to previous year's data and/or external data. Ultimately the goal is to determine the most frequent and costly losses.

Ms. Banerjee explained that spreadsheets, filters, and pivot tables can be used to analyze and assess this data. She then demonstrated some of these functions in Excel on a set of Workers' Compensation data.

The Illinois State University ASSE Student Section would like Ms. Banerjee for her time and informative presentation.

Appendix E: Bylaws

Bylaws Illinois State University Student Section of the Central Illinois Chapter, ASSE.

#### ARTICLE 1 - NAME

Section 1. The name of this Section shall be the Illinois State University Section of the Central Illinois Chapter, American Society of Safety Engineers.

Section 2. Hereinafter, the Student Section shall be referred to as the <u>Section</u>, the American Society of Safety Engineers shall be referred to as the <u>Society</u>. The Central Illinois Chapter shall be referred to as the <u>Chapter</u>, the Area Operating Committee shall be referred to as the <u>AOC</u>, the Regional Operating Committee shall be referred to as the <u>ROC</u>, and the Illinois State University/College shall be referred to as the <u>School</u>.

#### ARTICLE II - PURPOSES AND GOVERNMENT

Section 1. The purposes of this Section shall be to promote the advancement of the safety profession and safety education and to foster the professional growth and development of its members within its campus and community.

Section 2. In fulfilling its purposes, the Section shall have the following objectives:

- a.) To further the professional preparation of the members by sponsoring programs for the advancement of safety and acquisition of technical knowledge.
- b.) To improve scholarship and the general quality of work in the Safety Profession by fostering a concern for progress in all areas of safety, among safety educators and practitioners.
- To encourage greater professional and social cooperation and interaction among students of safety and allied fields and disciplines.
- d.) To unite the resources and skills of students and faculty in programs to benefit Section members, the school and its community.
- To assist the Society in the development of effective and relevant educational programs for the preparation of future safety professionals.
- f.) To provide encouragement and support to society student activities and foster student member development and retention on its local campus.
- g.) To promote participation and entrance into safety/health careers by high school and college students.
- h.) To cooperate with other professional societies and organizations to further the purposes of the society
- To conduct, assist, and support educational activities designed to equip individuals with the knowledge necessary to practice safety.
- j.) To promote the observance of the "canons of ethics" adopted by the society.
- k.) To set up speaking engagements for the purpose of promoting an interest in safety within the section and the university.

- Section 3. This organization shall be governed by this constitution and bylaws and regulations of the Chapter and the ASSE.
- Section 4. The headquarters of the Section shall be located at Illinois State University, Department of Health Sciences, 305 Felmley Hall, Normal IL 61790.
- Section 5. The official symbol of the section shall be the same as that of the Chapter and Society.
- Section 6. Nothing in these bylaws is intended to substitute for, or supersede, rules or procedures established by the school that impacts upon the Student Section.

#### ARTICLE III - MEMBERSHIP DUES AND FEES

- Section 1. Section membership is open to all Student Members of the Society, who are enrolled in the safety or related curricula at the school identified in the Section's name. To be eligible as a Society Student Member, an individual shall be enrolled in an undergraduate or graduate safety course intended to prepare the individual for practice in the safety profession or on of its relevant specialties, shall pay an annual renewal fee as designated by the Society Board of Directors.
- Section 2. Section members shall be assessed an annual student member renewal fee by the Society as determined by its Board of Directors. In addition, applicants for Student Membership may be assessed membership application fees as determined by the same Board. Fees shall be paid annually on the anniversary of the Student Member's election date.
- Section 3. The Section may assess its members additional annual fees and dues, upon recommendation of the Section Executive Committee and approved by a majority of Section members voting at a meeting where a quorum is present.
- Section 4. The Section Executive Committee, through the Section Treasurer, is responsible for all Section financial activities, under guidelines established by the Society, Chapter, these Bylaws, and the Section Executive Committee.
- Section 5. The Section shall provide an annual financial report to the Chapter, Area Operating Committee (Regional Operating Committee) and Student Member Activities Committee, describing all Section income and expense activities for the preceding twelve

- (12) months. This report shall be reviewed and signed by the Section Advisor and submitted to the Chapter by April 15.
- Section 6. Student Member status, may be retained up to one year following graduation, or until the individual is employed in the field of safety, whichever comes first.
- Section 7. Section membership is personal and non-transferable...
- Section 8. Section members are eligible to vote on all matters brought before them. A majority affirmative vote is necessary for action unless otherwise specified in these bylaws. On Chapter and Society issues, Student Members are eligible to vote only on the election of officers.

#### ARTICLE IV - ORGANIZATION

- Section 1. The Section is a subdivision of the Chapter, formed and operated by ASSE Student Members attending an educational institution located within the Chapter's geographical area.
- Section 2. The Section shall have and maintain a minimum of five (5) members in order to maintain its charter.
- Section 3. In order to maintain its charter, the Section shall identify an advisor (defined in Article V, Sec. 6) and shall provide the Chapter and Society annually with information on the advisor's name, address and telephone number.
- Section 4. Formation and maintenance of the Section charter is based on requirements and guidelines set forth in the <u>Chapter Administration Guide</u>, and is subject to the approval of the Chapter and the appropriate AOC (ROC).
- Section 5. The Section may be dissolved by the Chapter and /or the AOC(ROC), if such action is deemed to be in the best interests of the Chapter and Society. Voluntary dissolution of the Section shall be by two-thirds of Section members after a 30-day advance written notice by the Section Executive Committee. Voluntary dissolution is subject to the approval of the Chapter and AOC (ROC). Upon dissolution, all Section funds and assets shall be returned to the Chapter, school, ASSE Foundation or other ASSE entity, depending on the funding source.

Section 6. The Section fiscal year shall begin on April 1 and end on March 31. The Section activity year shall begin on April 1 and end on March 31.

#### ARTICLE V - OFFICERS

- Section 1. Elected Section officers shall be a President, Vice President, Secretary and a Treasurer. Requirements for Officers are as follows:
  - a.) President and Secretary: Any permanent member may be elected to these offices.
  - b.) Vice President: This office should be filled by any permanent member of the Section who knows to the best of his knowledge he will be able to complete his term of office.
  - Treasurer:
     Any Permanent member may hold this office.
- Section 2. Elections for all officers will be held during the last meeting of the school year.
- Section 3. Prospective officers will be asked by the Executive Committee if they will accept their nomination to office, how long they will be able to retain their office and state their qualifications for the office they intend to hold.
- Section 4. Vacancies caused by non-returning officers to the University and those who can not fill their office for the remainder of the term will be filled by the Executive Committee calling a special election meeting.

#### Section 5. Duties of officers:

a.) The President shall call, set agendas for, and preside at meetings of the Executive Committee, and preside and set agendas for meetings of the Section membership; shall set goals and objectives for the section and provide leadership, guidance and direction to officers, committees and members to see that they are met; shall appoint members of the Nominating Committee; shall serve as chief spokesman and representative of the Section to the Chapter, Society and allied groups; and shall submit an annual report of Section activities to the Chapter and Student Member Activities Committee. The president shall serve in the capacity of a non-voting member on the Safety Program Advisory board for the duration of an entire academic year. The president will begin in this capacity at the May advisory board meeting following the April student meeting elections. The president would be invited to attend the following May meeting when the newly elected president would assume the duties.

- b.) The Vice President shall succeed to the office of the President if the President is unable to serve; shall act for the President when requested to do so by the Executive Committee or members; and shall in general prepare to ascent to the Section Presidency in the following year.
- c.) The secretary shall record, transcribe and distribute minutes of all Section meetings, prepare and distribute meeting notices, maintain all Section records and conduct Section membership development and retention activities under the supervision of the Executive Committee.

NOTE: The President-Elect or Vice President may also supervise the work of Section appointed committees or project Chairpersons, if desired.

d.) The Treasurer shall collect and disburse all Section funds, maintain Section financial records including all income and expense activities, collect Section-generated membership fees and dues, handle all Section liaison with financial institutions, submit an annual report of all Section financial activities to the Executive Committee, and keep the Section and the Chapter regularly informed as to the Section's financial status.

#### Section 6. There shall be a Section advisor who shall be either:

- An ASSE member who is a faculty member of the school where the Section is located, or
- A formally designated member of the Chapter in whose geographical area the Student Section's school is located.

The advisor shall be an ex-officio member of the Section Executive Committee, and shall serve as liaison between the Section, appropriate school officials, and the Chapter. The advisor shall approve Section activity and financial reports, fundraising activities, and be consulted on all matter relating to Section dues, fees, and Bylaws. The advisor shall ensure that Section activities do not violate School rules and regulations governing on-campus clubs, groups, and activities.

#### ARTICLE VI - NOMINATION, ELECTION AND REMOVAL OF OFFICERS

- Section 1. The Nominating Committee shall be appointed by the Chairperson/President annually for the purpose of recommending a slate of one or more nominees for each Section elective office. Publication of the slate, including background and qualifying information on each nominee, shall be completed no less than thirty (30) days before the election is conducted. The election and installation of officers for the succeeding Section activity year shall be completed before the end of the current school year.
- Section 2. The term of service for officers shall be for one (1) year beginning July 1.
- Section 3. Five to seven (this should be the number of student members who can submit the petition) Student Section members may submit a signed petition nominating one or more members for elective office. The petition shall be accompanied by a written acceptance by the nominee (s) and shall be submitted to the Nominating Committee Chairperson no less than fifteen (15) days before the election is conducted. The names and qualifications of the petition nominees shall be distributed to all members within seven (7) days of their receipt.
- Section 4. All Section members shall be given the opportunity to vote on the election of officers, through written ballots distributed on campus and/or at a Section meeting.
- Section 5. Three Section members, who are neither candidates for elective office, nominating committee members, no current Section officers, shall be appointed as Tellers to count ballots confirm the propriety of election/nomination procedures, and announce election results.
- Section 6. Elected Section officers may be removed by majority vote of Section members at any regular or special meeting upon presentation of a signed petition from the Section Executive Committee or this should be five to seven Student Section members. Notification of such meeting shall be made to all members at least fifteen (15) days in advance of the meeting.

Appointed Section officers may be removed by the officer who appointed them, or by the Section Executive Committee.

Section 7. Vacancies in elected Section offices occurring during the elected term shall be filled by the succession designated in Art.V, Sec.5. The resulting Vacancy in the office of Treasurer shall be filled by affirmative vote of a majority of Section members upon a nominating slate of one or more candidates submitted by a special member Nominating Committee appointed by the Chairperson (President). The election shall be held at a regular or special Section meeting, notice for which shall be published at least fifteen (15) days in advance.

#### ARCILE VII - COMMITTEES

- Section 1. Elected Section officers and the Section advisor shall make up the Executive Committee, which shall govern the Section according to these bylaws and within the authority delegated to it by Section members.
- Section 2. The Section shall have a Nominating Committee, appointed by the Chairperson (President), for the purpose of developing a slate of Section officers annually for member election. The committee shall consist of three Section members, one of who shall be a current or past Section officer. The committee shall elect its own Chairperson.
- Section 3. There shall be an Executive Committee, consisting of the elected officers.
- Section 4. The Executive Committee shall meet at least 6 times a year to transact the business of the Section. A quorum shall consist of a majority of the members of the Executive Committee.
- Section 5. The Executive Committees shall be responsible for the policies and programs of the Section. The Executive Committee shall have full authority to act for the Section and to take all steps it deems necessary or appropriate to carry out the Section's purposes. The Executive Committee shall be responsible for the finances of the Section.
- Section 6. The President shall appoint the Chairs of such standing committees as are established in the bylaws, and such special temporary committees as may be necessary to accomplish the purposes of the Section.

#### ARTICLE VIII - AMENDMENTS OF CONSTITUTION

Section 1. This Constitution may be amended by approval of 2/3 affirmative votes cast by permanent members at a regular meeting of the Section. Amendments may be proposed either by resolution of the Executive Committee, or by petition signed by not less than 5 permanent members of the Section. All proposed amendments shall be submitted to the secretary in writing. Amendments originating in the Executive Committee shall be certified by the President before they are submitted to the secretary.

Section 2. All proposed amendments received by the Secretary shall be submitted in writing to each member at least 14 days prior to the meeting at which a voice vote shall be taken on the proposed amendment.

#### ARTICLE IX AMENDMENT OF BYLAWS

Section 1 The bylaws may be amended by a proposal of the Executive Committee. The amendment shall be presented and read at a regular meeting of the Section. The proposed amendment shall then be voted on at the next regular meeting of the section by a voice vote. A majority vote of members present shall prevail.

Section 2. Amendments shall be published at least fifteen (15) days in advance of the meeting at which action will be taken on them.

Section 3. Amendments shall be voted on at a regular or special Section meeting where a quorum is present. A majority (option – two-thirds) 2/3 affirmative vote is required for approval.

Section 4. All amendments approved by Section members are subject to approval of the Chapter Executive Committee and Area Director (Regional Vice President).

#### ARTICLE X - MEETINGS

Section 1. The Section Executive Committee shall meet upon the call of the President or upon a majority vote of its members.

Section 2. The Executive Committee shall hold at least two (2) meetings of its members annually, to acquaint them with its activities and conduct necessary business. Five to seven section members at a meeting shall constitute a quorum.

- Section 3. Special meetings of Section members may be called by the Section Executive Committee or by written petition of five (5) members, submitted to the Section President.
- Section 4. Section member meetings and votes shall be required to accomplish the following actions: amendment of these bylaws, establishment of or change in Section dues or fees, removal of elected officers, and Section dissolution.
- Section 5. The Section shall hold six (6) meetings throughout the academic year, which consists of the spring and fall semesters.
- Section 6. Robert's Rules of Order Newly Revised shall govern the transactions of business at Section meetings, unless otherwise specified in these Bylaws.






